- **Rs 20000 Crore Gujarat State Petrol Corporation (GSPC) Scam** under the watch of the then CM Shri Narendra Modi as unraveled by CAG. Instead of taking action, PM Modi has ensured purchase of a bankrupt GSPC by the *Navratana* company ONGC to the tune of Rs 7738 Crore

- **India’s biggest medical admission and jobs scam i.e Vyapam Scam** under the watch of Madhya Pradesh CM, Shri Shivraj Singh Chouhan in which over 50 people have lost their lives
- **Rs 36000 Crore ‘PDS Rice Scam’** of Chhattisgarh under the watch of BJP CM, Dr Raman Singh
