**Modi –Shah duo is engulfed by ‘Clutches of Corruption’**

**‘Dented- Tainted’ leaders rule the roost in BJP !**

**BJP - ‘BHRASHT JANARDHANA PARTY’**

Modi-Shah duo is walking on the ‘Clutches of Corruption’- one side is ‘Yeddy Gang’ & the other side is the ‘Reddy Gang’!

BJP’s list of candidates in Karnataka is a ‘who’s who’ of ‘dented-tainted’ leaders facing prosecution at multiple levels, for their misdeeds.

**‘Republic of Bellary’ has the blessings of PM Modi with 8 Assembly tickets and a puppet CBI working overtime to wash the sins of ‘Reddy brothers’. No wonder, CBI has surreptitiously withdrawn 6 CBI cases of Goa-Karnataka-Tamil Nadu in India’s biggest Rs 35,000 Crore ‘Illegal Iron-ore Mining Scam’.**

Fearing imminent defeat; ‘Duplicity’, ‘Deception’ & ‘Double-Speak’ of Prime Minister, Shri Narendra Modi can be gauged from the fact that –

- (i) PM Modi has restricted his campaign to merely 5 days;
- (ii) PM Modi has refused to share stage with his own CM candidate, Yeddyurappa;
- (iii) Modi –Shah duo, first cleared Yeddyurappa’s son’s ticket from Varuna assembly and then denied in face of public reprisal;
- (iv) Modi-Shah and other BJP leaders are avoiding to go to Bellary like a plague despite giving 8 assembly tickets to ‘Reddy Gang’;
- (v) Modi-Shah is chickening out from clear association with G. Janardhana Reddy as CM candidate, Yeddyurappa publically embraces him & Janardhana Reddy emerges as the principle campaign manager for the BJP.

**As PM Modi arrives today, 6.5 Crore Kannadigas demand answers:-**

### **1. Shri B.S Yeddyurappa**

There are as many as **23 cases of ‘Corruption, Cheating and Forgery’** pending against BJP CM face, **Shri B.S.Yeddyurappa** in various courts. List Attached as **Annexure A1**.

Further, is it not correct that as many as 15 cases of Corruption registered against Shri B.S Yeddyurappa are now pending adjudication in Supreme Court?

**Despite knowing all this, Modi-Shah duo declared him as CM face. Why?**

**2. Shri Sriramulu, Former Minister, BJP (Close associate of Janaradhana Reddy)**

He is BJP candidate from Badami & Molkaluru. He has 3 criminal cases pending against him under Prevention of Corruption Act & Criminal Trespass pending in the courts at Bellary.

**3. Shri Somashekar Reddy (Brother of G. Janaradhana Reddy)**

He is BJP candidate from Bellary City. There are 5 criminal cases pending against him under Prevention of Corruption Act, Arms Act, Offering Bribe to a Public Servant, Forgery, Theft, Dishonest Misappropriation of Property, Criminal Breach of Trust and Mines & Minerals Act, pending against him in Hyderabad (Andhra Pradesh), Bellary & Bangalore. He was also in jail in Andhra Pradesh in Special CBI-Judge-Bribery-Case.

**4. Shri T H Suresh Babu (Associate of Janaradhana Reddy & Nephew of Sriramulu )**

He is BJP candidate from Kampli. There are 6 criminal cases pending against him under Prevention of Corruption Act, Forgery, Falsification of Accounts, Cheating, Theft, Criminal Breach of Trust, Criminal Trespass pending against him in Hyderabad (Andhra Pradesh), Bellary & Bangalore. He was also in jail in Andhra Pradesh in Special CBI-Judge-Bribery-Case.

**5. Shri Katta Subramanya Naidu, Former Minister for Housing, BJP**

He is BJP candidate from Shivaji Nagar, Bangalore. He has 4 criminal cases pending against him under Prevention of Corruption Act, Prevention of Money Laundering Act (PMLA), Cheating and Forgery. He and his son has also been 'Jail Birds'. A 5<sup>th</sup> case is pending in Supreme Court.

**6. Shri C T Ravi, Former Minister, BJP**

He is BJP candidate from Chikkamagalur. He has 3 criminal cases pending against him under Prevention of Corruption Act, Forgery, Cheating, Criminal Breach of Trust and Criminal Conspiracy.

**7. Shri Murgesh Nirani, Former Minister, BJP**

He is BJP candidate from Bilgi, Bagalkot. He has 2 criminal cases pending against him under Prevention of Corruption Act and other offences.

**8. Shri ES.EN.Krishnaiah Setty Malur, Former Minister, BJP**

He is BJP candidate from Malur. There are 4 criminal cases pending against him under Prevention of Corruption Act, Cheating, Forgery and Criminal Breach of Trust. He is also a former 'Jail Bird'.

**9. Shri Shivana Gouda Nayak, Former Minister, BJP**

He is BJP candidate from Devadurga. There are 3 criminal cases pending against him under Prevention of Corruption Act, Cheating and Criminal Breach of Trust.



**10. Shri R. Ashok (Former Deputy CM, BJP)**

He is BJP candidate from Padmanaba Nagar. He has 2 cases pending against him i.e a criminal case and a petition registered by Lokayukta police for Prevention of Corruption Act & Cheating.

**11. Ms Shobha Karandlaje, Former Minister, BJP**

She is presently MP. A case under Section 45 of Prevention of Money Laundering Act is pending against her.

**'Modi Govt puts a lid on the Rs 35,000 Crore Illegal Iron-ore Mining Scam'**

Out of 9 cases of brazen loot of Iron-ore worth Rs 35,000 Crore through 9 ports in the states of Karnataka, Goa, Tamil Nadu & Andhra Pradesh; a puppet CBI has shut down 6 cases in Goa, Karnataka & Tamil Nadu.
