Highlights of the Sound Byte

November 25, 2016

Shri Randeep Singh Surjewala, MLA and In-charge Communication Deptt. AICC, Prof. Rajeev Gowda, MP and Ms. Sushmita Dev, MP addressed the media.

श्री रणदीप सिंह सुरजेवाला ने पत्रकारों को संबोधित करते हुए कहा कि नोटबंदी के नाम पर मेहनतकशों की लूट और लुटेरों को छूट का जो अभियान शुरू किया गया था, उसकी परतें आए दिन खुलती जा रही हैं। अब ये साफ है कि कहीं ना कहीं भारतीय जनता पार्टी और कालेधन का चोली-दामन का साथ है।

नोटबंदी से एकदम पहले भारतीय जनता पार्टी के कोलकता स्थित खातों में कैसे लगभग 3 करोड़ रुपया 500 - 1000 रुपए के नोटों में डालकर बदलवाया गया, ये पूरे देश ने देखा और ये भी पूरे देश ने देखा कि आम जनमानस 2000 रुपए तक दिनों में लाईनों में धक्के खा रहा था और भाजपा नेता गठ्ठे के गठ्ठे लेकर सोशल मीडिया पर फोटो खिंचवा रहे थे। लेकिन अब जो बड़ा खुलासा सामने आया है उससे इस रहस्य की बाकि परतें भी खुल गई हैं।

भारतीय जनता पार्टी ने नोटबंदी से एकदम पहले बिहार और देश के अलग-अलग कोनों में करोड़ों- अरबों रुपयों की संपत्ति खरीदी और उसको खरीदने के लिए चैक और कैश दोनों का इस्तेमाल किया गया। कालाधन सफेद करने का इससे नायाब तरीका हो नहीं सकता और 3 करोड़ 41 लाख की 8 ट्रांजेक्शन मात्र बिहार प्रांत की हमारे सामने है।

पहली ट्रांजेक्शन 6 सितंबर 2016 को लखी सराय में 60 लाख 13 हजार रुपए की जमीन भाजपा अध्यक्ष के द्वारा थ्रू संजीव चौरसिया खरीदी गई। 14 सितंबर 2016 को मधेपुरा में 85 लाख 15 हजार की जमीन दलीप कुमार जैसवाल, 11 अशोका रोड़ जो भाजपा का कार्यालय है द्वारा खरीदी गई। 16 सितंबर 2016 कटिहार में 41 लाख 48 हजार और 74 लाख 65 हजार की जमीन भाजपा के कोषाध्यक्ष दलीप कुमार जैसवाल के माध्यम से

खरीदी गई। 19 सितंबर 2016 अरवाल में 25 लाख 7 हजार की जमीन भारतीय जनता पार्टी, 11 अशोका रोड़ के द्वारा खरीदी गई। 19 सितंबर 2016 को 39 लाख की जमीन किशनगंज में भाजपा अध्यक्ष अमित शाह जी के द्वारा खरीदी गई और 19 सितंबर को अरवाल में ही लगभग 80 लाख की जमीन भाजपा द्वारा इसी प्रकार खरीदी गई और 1 अक्टूबर 2016 को मधुबनी में इसी प्रकार से 73 लाख 50 हजार रुपए में जमीन खरीदी गई। ये दर्शाता है कि भारतीय जनता पार्टी किस प्रकार से करोड़ों-अरबों रुपयों की संपत्ति खरीद कर अपना कालाधन सफेद कर रही थी।

हम फिर ये मांग करते हैं कि ये पैसा कहाँ से आया, मोदी जी और अमित शाह जी जवाब दें? ये भी जवाब दें कि पूरे देश में कितनी संपत्तियों के सौदे पिछले 6 महीनों में भाजपा और उनके पदाधिकारियों द्वारा किए गए? भाजपा की राष्ट्रीय और उनकी क्षेत्रिय ईकाईयों के सारे खाते, लेन-देन का हिसाब, पिछले 1 साल का सार्वजनिक किया जाए ताकि दूध का दूध और पानी का पानी सामने आए और कालेधन से लड़ने का ढोंग करने वाले मोदी जी और भाजपा की असली असलियत सामने आए। मोदी जी और अमित शाह जी ढोंग छोड़िए, कालेधन की सुई सबसे पहले 11 अशोका रोड़ से चलती हैं और ये नहीं अनेकों परतें जो खुलती जा रही हैं वो दिखा रही हैं और इसलिए देश आपसे जवाब मांगता है कि भाषण देना बंद कीजिए और यथार्थ, वास्तविकता सामने रखें।

Ms. Sushmita said Mr. Narendra Modi Ji withdrew 86% of the cash flow from the economy and one of the primary reasons he proposed to the Nation that it was a Surgical strike on Black-Money whereas Prime Minister is well aware, as Black-Money is only 6% of the 86% and today the revelation made by one of the Members of the Bihar Assembly who belongs to the BJP - Mr. Chaurasia - has proved that in that 6% Black-Money that is there in circulation, BJP has a share and not just a small share - a huge share. Shri Narendra Modi, as Prime Minister, is well aware that Black-Money is not stashed away in the cup-boards of the common man, the Black-Money is stashed away in property, in jewellery and he has proved that BJP is part of that procedure of parking Black-Money and converting Black-Money to white money.

Today, Narendra Modi Ji says that it is a small inconvenience to the common man and the inconvenience is worth the while for the greater National interest. The reasons he gives for it is - secrecy - but the question is that today the revelations of the investment made by BJP where land has been transferred in the name of none less than Amit Shah Ji who is the National President of the BJP. This is the biggest scam that India has seen because this is the biggest insider

dealing the Prime Minister Narendra Modi Ji and Amit Shah Ji have done to park BJP's Black-Money. Therefore, land deals, all of which took place, may be one or two months before the 8th of November, flies in the face of Narendra Modi Ji's theory that he is today inconveniencing the farmer, today he is inconveniencing the common man who has his daughter's marriage, today he has inconvenienced people who are waiting to be treated in Hospitals, today he has inconvenienced the common man in the name of secrecy, a secret that he shared with Amit Shah Ji, the National BJP President.

We say it again to the Finance Minister and to the Prime Minister of India, you have just shown the country the biggest scam India has ever seen because you have shared confidential information about demonetization and that is how these land deals were done and you should be ashamed because today you are not facing the Parliament, today you are not facing the Parliament for this reason because every single day, what is coming before the people of India that it is BJP which has repeatedly, whether it is depositing of cash by the West Bengal BJP and whether it is this land deals not just in Bihar but all over the country, that shows it is BJP which is the corrupt Party, which is today delving dealing in Black-Money and today I hope that the Prime Minister with state in the Lok Sabha and the Rajya Sabha, what is the explanation of these land deals undertaken by various BJP Leaders.

Prof. Gowda said this morning the Prime Minister Shri Narendra Modi, in a Book release function, made a mocking attack on the Opposition. He said that if the Opposition had 72 hours, it would have made preparations to manage its Black-Money. I would urge Mr. Narendra Modi to look in the mirror.

If anyone has had that information and had that time to go out there and convert the Black-Money, it is the BJP, it is under the Leadership of Shri Amit Shah and Shri Narendra Modi, where you have seen the number of properties where cash has been paid and you can be clear that lot of cash was not declared for those transactions as well. It is clear that the BJP has had the advance information from the Prime Minister, has put in place the measures to convert its huge cash holdings and stashes of Black-Money into white. The Prime Minister, when he makes these accusations against the Opposition should turn around and acknowledge that the biggest pound of Black-Money is with the BJP. We are seeing that today is just the tip of the iceberg. In the days to come, we will see more and more revelations of cash transactions indulged in by BJP functionaries. You already saw that in the case of Kolkata that One Crore is being deposited. It is very clear that this move is aimed at converting their Black-Money and then trying to act as if you can attack the Opposition on this kind of a measure. Prime

Minister's move has destabilized the entire economy, it has hurt the poorest of the poor, the marginal citizen of India and India is going to take a very long time to recover but more than anything else, let me assure you that we will continue to probe the Black-Money dealings of the BJP that are now tumbling out of the closet and are showing to the people of India what series of mega hypocrisies the Prime Minister has indulged in his public speeches on this issue when he makes accusations against the Opposition. Look in the mirror Mr. Modi Ji and you will see who is holding the Black-Money, who is playing with that Black-Money and who is responsible for the disaster that has been unleashed on the Indian economy.
